Spiritual Growth and Development (SGD) in Action

Each new year offers a fresh beginning. At UUAA we enjoy an influx of visitors. Most of the visitors are new to Unitarian Universalism. Those with children often ask about our SGD Children and Youth Program, specifically, "what do you teach the children?" The SGD program strives to provide community and a supportive environment for families - parents and guardians remain the primary religious educators of their children, UUAA programming does not usurp this role. During this season of exploration, I offer this abridged list of resources available to parents and guardians as they engage their role as primary religious educator and spiritual guide for their children.



The Unitarian Universalist Association (UUA) provides many resources easily found on its website: [uua.org](http://www.uua.org). For example, the UUA Families site (<http://www.uua.org/re/families/index.shtml>) discusses how to support children in the face of disaster or tragedy, such as a tornado or school violence. Similarly, there are resources on adoption, death and parenting, among others.

The UUA Bookstore offers many books about parenting with a UU lens. My current favorite is *Don't Fix Me, I'm Not Broken* by Sally Patton. This book probes the spiritual practice of parenting a child with different needs, including the labels of disability, disorder or disease. The UUA also provides sexual orientation and gender identity resources, including book titles for youth and adults on LGBTQ topics (<http://www.uua.org/lgbtq/discuss/25458.shtml>). I can also recommend *The Gift of Faith: Tending the Spiritual Lives of Children* by Jeanne Harrison Nieuvejaar, and *About Death: A Unitarian Universalist Book for Kids*.

What are your beliefs? Practices? Do you meditate? Do you read the Bible? Is a walk in the "Back 40" a spiritual practice for you? Do you identify as a Humanist? Atheist? Christian? None of these? Do you have a chalice in the home? A copy of the hymnal? Do you teach in the Children and Youth Program? Have you discussed with your children WHY you teach? Not only does sharing your experiences and beliefs with your child provide her/him with information about you, it models how to discuss spirituality without judgment and with conviction.

In our home, we have a hymnal and a chalice. Both of our children pledge to the UUAA, one to the annual fund, one to the capital campaign. We take the opportunity to discuss why we are Unitarian Universalists, what it means to support our congregation, and why we do it. We also learn about other faith traditions. Videos of Bible stories are the current favorite. We are able to discuss differences in a respectful manner. It is never too early! My son and his friends had a heated debate about different faith traditions over the second-grade lunch table. here was arguing among many and confusion as to why everyone couldn't just get along. Like so many life experiences, it provided opportunity for discussion and sharing.

Hello, all. My name is Erin Dixon, and I have been the Lead Teacher for the UUAU Pre-School classroom since 2008. Your children may know me as Miss Erin. I also coordinate the Childcare Providers program. When you see "Child care is available" on a UUAU flyer or in a notice, that is the Childcare Providers program at work.



The Childcare Providers program is separate from the Spiritual Growth and Development Program. SGD is offered every Sunday, while Congregational groups who want childcare for their events must contact me at erin@uuaa.org as well as Programs Coordinator Maria Thomas at maria@uuaa.org in advance to arrange for childcare. The Childcare Providers program is now hiring childcare providers. These are part-time positions offering one to six hours employment per month. Providers always work on-site here at UUAA. Applicants must have completed child CPR and first aid training within the last year, and will undergo a background check.

Denominational Connections Team (DCT)

At the January 19 Congregational Meeting vote for five out of six proposed Congregational Study/ Action Issue (CSAI) for 2014 - 2018. The Denominational Connections Team (DCT) will offer a forum on January 12 after the second service. Here are six issues for consideration:

1. Proposed CSAI: *Empowerment: Age and Ability Reconsidered*: The personal is political. Young people and older people know what it's like to be abused, marginalized, and discriminated against because of their age and ability. How can congregations best empower young and old? How can people with different abilities, in different age groups, create the Beloved Community? uua.org/statements/current/290504.shtml.



2. Proposed CSAI: *Ending the War on Terror*: Since September 11, 2001, the United States has been engaged in a "war on terror," with the doctrine that "the world is a battlefield." Torture, extraordinary rendition, detention without trial, extrajudicial assassination by drone strike, dragnet surveillance of phone and internet communications, and military intervention have been conducted in the name of combating terrorism. The military consumes a vast share of the discretionary Federal budget. Yet, because much of this war is conducted in secret and constitutes killing by remote control, it is often virtually invisible in Americans' daily lives, despite our collective responsibility for it. Making the invisible visible as the basis for moral choice is central to the religious practice. uua.org/statements/current/290505.shtml
3. Proposed CSAI: *Escalating Inequality*: Upward mobility-the American Dream-has become a myth. Concentration of wealth and power has skyrocketed. King's dream of justice and equality has fractured. Half of all Americans are impoverished or struggling, as the middle class shrinks and billionaires take the profits. Where's our commitment to the Common Good? uua.org/statements/current/290506.shtml
4. Proposed CSAI: *Gun Violence: A Public Health Issue*: We are in the midst of an epidemic of violence fueled by the gun industry. The problem of gun violence is a public health issue. We can approach the situation the same way we challenged the tobacco industry, namely by exposing the facts. Because of the facts we have learned to wear seat belts, we have safer highways. We have learned the dangers of smoking, and that foods and drugs need to be regulated. It is our right as citizens to have access to this data and to all facts regarding consumer products. It is how we make informed decisions. It is unbelievable to me that guns and firearms are not regulated by the Consumer Product Safety Act. The gun industry has strategically protected itself from the consequences of its very harmful products. I believe the industry will not be able to stand up to the scrutiny of an informed public. Lets learn the facts and take on the national gun industry. uua.org/statements/current/290502.shtml
5. Proposed CSAI: *Renewing and Securing Our American Democracy*. Negative campaigning, voter suppression efforts, huge infusions of cash from super-rich donors and narrow special interests into the election and political processes, hyper-partisan politics, the alienation of ordinary citizens, decreasing voter turnout, and the erosion of civil liberties-all contribute to a growing fear that the American democracy and government of, by, and for the people are in jeopardy. What can Unitarian Universalists, with commitment to justice, equity, and the use of the democratic process in society at large, do to protect, renew, secure, and further democracy in America. uua.org/statements/current/290503.shtml
6. Proposed CSAI: *UU Values & the Pursuit of a Just Peace for Israelis & Palestinians*. The conflict between Israelis and Palestinians, now in its seventh decade, has caused great suffering and injustice, with effects extending far beyond the local region. Palestinians continue to endure violence, occupation, and dispossession, while Israelis are threatened by the specter of violent attacks and growing international isolation. uua.org/statements/current/290499.shtml

The Congregational Study/ Action Issue (CSAI) for 2012 - 2016, *Reproductive Justice: Expanding our Social Justice Calling* will be in full swing at UUA during the 2013 -

2014 program year. There will be a series of monthly discussions with topics from the UUA's Commission on Social Witness's recommended CSAI curriculum.

Session 3: Jan 22 - Inherent Worth and Dignity

Session 4: Feb 19 - Reverence for Life

Session 5: Mar 19 - Right of Conscience

Session 6: Apr 16 - Conclusion: Moving Forward

Partner Church News



Plans for the Thursday, June 5 through Monday, June 16 pilgrimage to the Partner Church congregation in Transylvania are underway. About a dozen people have expressed an interest, picked up a brochure, or sent an email about the trip. January will be the month to talk together about the trip and make reservations. Look for more information about meetings in the weekly bulletins.

This is a pilgrimage to historic Unitarian sites and home visits with the Partner Church congregants in their home town of Kézdivásárhely...and not a typical 'tour'. The trip is 12 days/10 nights and is offered by the UU Partner Church Pilgrimage Service. Land package costs are as follows:

- Land package per person for adults: \$1525 + \$150 registration fee for double occupancy.
- Additional \$140 for single supplement in hotels.
- Additional cost of \$110 to upgrade from the Unitarian dorm to the hotel in Kolozsvár and from home-stays to the B&B in the village of Székelyderzs.
- Land package per/person for youth is \$1225 + 150 registration fee for double occupancy.

The land package does not include airfare or other transportation to Budapest or from Bucharest. Travelers will make their own flight arrangements. Those wishing to travel with the group will be provided with the specific flight details by the group leaders once they are available so that they can make similar reservations.

At the Annual Meeting on Sunday, January 19 each will have an opportunity to vote for a Congregational Study/Action Issue



(CSAI) proposal that addresses a major human rights issue; one that Americans are complicit in perpetuating. *Unitarian Universalist (UU) Values and the Pursuit of a Just Peace for Israelis and Palestinians* has been endorsed by several nationally prominent leaders and is designed to provide a constructive framework to learn about, discuss, and take action consistent with UU values on this critical justice issue.



Unresolved and greatly misunderstood, this human rights tragedy also draws billions of dollars away from pressing domestic needs such as education, health, and infrastructure. For a brief introduction into the realities of this issue and the similarities with apartheid South Africa, pick up a DVD of the film *Roadmap to Apartheid* at the UUJME table in the Social Hall.
